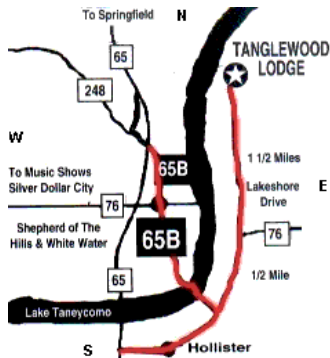

Lake Taneycomo's clear cold waters provide some of the finest trout fishing available anywhere in the world. The Rainbow Trout and Brown Trout that ply the waters of Lake Taneycomo provide an exciting, year-round fishing experience. From fly fishing and artificial-only fishing in the Trophy Trout Area near the lake's headwaters, to bait fishing outside of the Trophy area, Lake Taneycomo makes fishing for coveted Rainbow and Brown Trout a rewarding experience.

### Annual Spring Migration – Lake Icaria May 18-22, 2016

Make your reservations now for our annual Spring Migration to Lake Icaria, HWY 148, N of Corning, IA by calling 641-322-4793. There are 14 cabins available at **Lake View**, along with campsites and Marina facilities.

Water surrounds the campground on three sides. Lake View features full-service, electric, many water's edge tent sites and all new restrooms and showers.

Lake Icaria is a 648 acre lake with a maximum depth of 30 ft. **Walleyes were sampled in very high abundance with several exceeding 20 inches.** Largemouth bass were sampled in low to moderate abundance. Bass sampled were of all sizes with several exceeding 20 inches. Crappies were sampled in moderate abundance with some exceeding 12 inches. (2015).
