

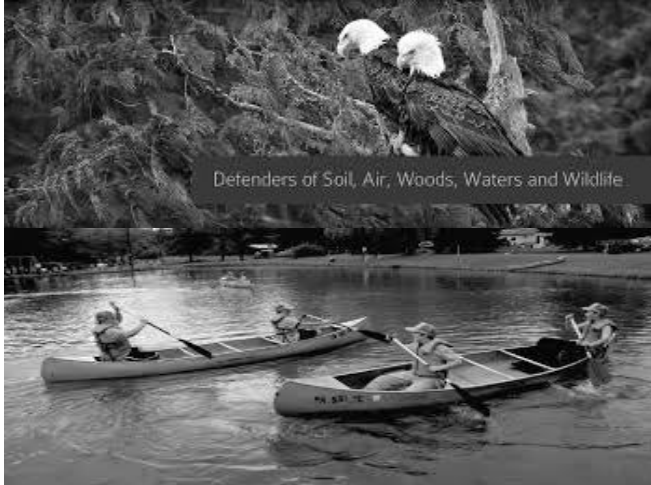

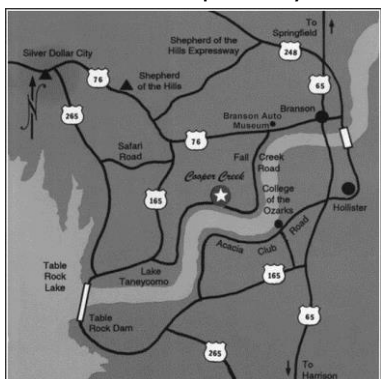
Annual Spring Trip to Lake Taneycomo April 13-16, 2016

Spring Clean Up Day Saturday, April 9, 2016

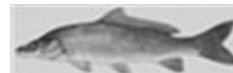
Volunteers are needed to help spruce up around the chapter house beginning at 9 a.m.
